April 26, 2022

MINUTES

Meeting called to order by Chairwoman Meuse at 7:30 p.m. with Superintendent-Director Jackson and the following members present: Ms. Asbedian, Ms. Bartolone, Mrs. Gillis, Ms. Kim and Messrs. Fiore, Fusco, Moffatt and O'Donnell. Ms. Lawson was absent.

Also in attendance were Mr. Tony McIntosh, Superintendent Director-Elect, Mr. Howard Greenspan, Attorney, and Ms. Tayla Tildsley, Student Representative.

The meeting began with the Pledge of Allegiance.

Motion made by Mr. Fusco, seconded by Mr. Moffatt, to open the Public Hearing on School Choice at 7:32 p.m. There being no public comment,

CHOICE 2022-2023

Motion made by Mr. Fusco, seconded by Mr. Fiore, to accept Dr. Jackson's recommendation that Shawsheen Valley Technical High School will not be a receiving district for the 2022/2023 school year for the following reasons:

- Choice would eliminate occupational/technical preferences for District students;
- Enrollment projections for the 2022/2023 school year indicate a full complement of students will be enrolling from the District;
- Maximum payment under school choice is less than the District towns pay to send a student to Shawsheen Tech.

Motion carried unanimously.

Mr. Fusco introduced Tayla and Sid Tildsley, two outstanding members of Shawsheen's Wrestling team. Tayla will be graduating this year and attending Phillips Academy in the Fall, and Sid will be a sophomore, hoping to add to his current 60-0 school record.

Student Representative Report

Ms. Tildsley updated the Committee on Spring sports that are underway, with all teams doing very well. Coach Costabile was inducted into the Massachusetts Football Coaches Hall of Fame, a great honor. Students will be enjoying a full calendar of activities this spring, with proms beginning on May 6<sup>th</sup>. The National Honor Society inducted 39 students this year, and the summer programs are almost full. Seventy-one students received medals at the SkillsUSA Districts, with the State competition beginning this week.

Superintendent's Report

Dr. Jackson updated the Committee on Covid numbers at Shawsheen since the last meeting with a slight uptick in cases this week after spring break. Dr. Jackson also commended Coach Costabile on his induction into the Massachusetts Football Coaches Hall of Fame. A "Day of Beauty" is planned in Cosmetology with lunch in the Rams Head, hoping to bring people back into the building. He updated the Committee on the status of the budget, with Bedford as the first to approve at their town meeting. He will be attending town meetings in Wilmington on Saturday, Tewksbury on Monday, Billerica on Tuesday and Burlington is scheduled for May 9. Dr. Jackson displayed all of the end of year activities that will be held for students through the balance of the school year.

Subcommittee Reports

The **Facilities Subcommittee** met this evening to go over the Authorization to Submit the Statement of Interest to the MSBA. After discussion,

Resolved: Having convened in an open meeting on April 26, 2022, prior to the SOI submission closing date, the School Committee of the Shawsheen Valley Regional Vocational Technical School District, in accordance with its charter, by-laws, and ordinances, has voted to authorize the Superintendent-Director to submit to the Massachusetts School Building Authority the Statement of Interest Form dated April 26, 2022, for the Shawsheen Valley Regional Vocational Technical High School located at 100 Cook Street, Billerica, Massachusetts, which describes and explains the following deficiencies and the priority category(s) for which an application may be submitted to the Massachusetts School Building Authority in the future:

Priority 2: Elimination of severe overcrowding;

Priority 5: Replacement, renovation, or modernization of school facility systems, such as roofs, windows, boilers, heating and ventilation systems, to increase energy conservation and decrease energy-related costs in a school facility; and

Priority 7: Replacement of or addition to obsolete buildings in order to provide for a full range of programs consistent with state and approved local requirements, and hereby further specifically acknowledges that by submitting this Statement of Interest Form, the Massachusetts School Building Authority in no way guarantees the acceptance or the approval of an application, the awarding of a grant or any other funding commitment from the Massachusetts School Building Authority, or commits the Shawsheen Valley Regional Vocational Technical School District to filing an application for funding with the Massachusetts School Building Authority.

Motion carried unanimously.

#### Old Business

##### UPDATE ON SCHOOL COMMITTEE ADMINISTRATIVE HIRES

Attorney Greenspan updated the Committee on the Administrative hires that the School Committee has the responsibility of hiring, which include the Superintendent-Director, the Business Manager, the Director of Special Education and also approves the hiring of an Assistant Superintendent-Director and has the sole authority to hire the school physician and the school's legal counsel.

##### RECOMMENDED ADJUSTMENTS TO APPROVED FY23 BUDGET

After discussion on the proposed changes:  
Motion made by Mrs. Meuse, seconded by Mr. Moffatt, to eliminate the position of Supervisor of Food Services and to replace it with the unaffiliated position of Director of School Food Services. Motion carried unanimously.

Motion made by Mrs. Gillis, seconded by Mrs. Meuse, to eliminate a Guidance Counselor position and replace it with the position of Director of Guidance

Motion amended by Mrs. Gillis, seconded by Mr. Moffatt, to eliminate a Guidance Counselor position and replace it with the position of Director of Guidance, and to direct the Superintendent-Director to report back to the Committee before the end of 2022 on the status. Motion carried unanimously.

Motion made by Mr. O'Donnell, seconded by Mrs. Gillis, to eliminate the position of In-School Security Monitor and replace it with the position of Assistant Principal for Students. Motion carried 7-2, with Ms. Asbedian and Mrs. Meuse opposed.

Motion made by Mrs. Meuse, seconded by Mrs. Gillis, to approve the last day of school on June 16, 2022 as a half day for students and a full day for staff. Motion carried unanimously.

TO BORROW

Motion made by Mrs. Meuse, seconded by Mrs. Gillis, that the District Treasurer is hereby authorized, under the provisions of General Laws, Chapter 71, Section 16(g), as amended by Chapter 134 of the Acts of 1972, and with the approval of the Chairman of District Committee, to borrow money from time to time in anticipation of revenue for the fiscal year beginning July 1, 2022, and to issue a note or notes thereof, payable within one year, and to review any note or notes as may be given for a period of less than one year in accordance with General Laws, Chapter 44, Section 17. Motion carried unanimously.

## MINUTES

Executive Session called to order by Chairman Fusco at 9:47 p.m. with Superintendent-Director Jackson and the following members present: Ms. Asbedian, Ms. Bartolone, Mrs. Gillis, Ms. Kim, Mrs. Meuse and Messrs. Fiore, Moffatt and O'Donnell. Also in attendance was Howard Greenspan, Attorney.

Attorney Greenspan reported to the Committee that he has received a request from the Massachusetts Teachers Association to organize the Paraprofessionals and the IT staff. He met on April 6<sup>th</sup> with the MTA and relayed that the Committee will voluntarily recognize the Paraprofessionals but did not agree to combine the Paraprofessionals and the IT staff. The Maintenance staff would like to organize as well. The STA prefers to put everyone into the teachers' union with sub-units. Attorney Greenspan would recommend keeping the paraprofessional as one unit and to combine IT and Maintenance as sub-units within the teachers union.

Motion made by Mrs. Gillis, seconded by Mrs. Meuse, to recognize the paraprofessionals as an individual unit and to recognize IT and Maintenance together as a sub-unit. With a roll call vote, Chairman Fusco, Ms. Asbedian, Ms. Bartolone, Mrs. Gillis, Ms. Kim, Mrs. Meuse and Messrs. Fiore, Moffatt and O'Donnell voted yes. Motion carried unanimously.

Mrs. Meuse requested that she be allowed to attend all negotiation meetings.
