

Traffic Calming – Speed Table Request

- Residents submit a Speed Table petition to Select Board demonstrating neighborhood support.
- Obtain Seventy-five percent (75%) or more of the property owners adjacent to the section of roadway using attached petition form. Abutting lots include all properties adjacent to the street although it may have different street address. (for example corner lots)
- Traffic Committee will conduct an evaluation to include traffic study and accident history to determine if the subject roadway is a potential project candidate.
- If supported by the Traffic Committee, an Engineer's Estimate will be developed and the residents can request a Select Board public hearing to present their petition.
- The Town will be responsible for abutter notification and public hearing legal advertisement as required.
- After receiving Select Board approval an article will be submitted to Town Meeting to fund the project.

Minimum Evaluation Criteria

- Secondary or Local road classification (Main and Dead End roads are ineligible)
- Residential neighborhood
- Posted speed 30 MPH or less
- 15% of vehicles exceeding by 5 MPH or more over posted speed limit.

Additional Considerations

- Traffic Volume 50% greater than comparable streets.
- Accident rate greater than comparable streets.
- Proximity to School, Park, or other pedestrian attraction location.

Design Standards

- Adequate sight distance for the 85th percentile speed.
- Street slope 8% or less
- Spacing 300 – 500 feet
- Coordinate installation with paving/utility work that is scheduled within next 5 years.

Speed Table Request

Instructions:

1. **Is Street a viable candidate?** (See pages 4 and 5 *Streets ineligible for Speed Tables*)
2. **Resident Contact:** provide contact information for neighborhood representative.
3. **Project Limits:** Identify location (entire street, cross street to cross street, other)
4. **Justification:** Describe concerns and need for traffic calming measures
5. **Petition Form**
 - Obtain Seventy-five percent (75%) or more of the property owners adjacent to the section of roadway using attached petition form.
 - One signature is allowed per address.
 - Abutters list can be obtained at the Town Assessors Office or by using the Planning Department's interactive Mapping Tool available on the Planning's web site.
6. **Submit Request and Petition Forms** to Select Board Office.
