Dear Liz:

This office and the undersigned represent Foxboro Learning, LLC (“Applicant”) concerning the development of the property located at 0 Cambridge Street, Burlington, MA, comprising approximately 3.82 acres and identified on the Town’s Assessor’s Map as Parcel ID: 35-115-0 (the “Property”). The Property is situated in the Residential – One Family Dwelling (RO) Zoning District and Water Resource Overlay District.

For your consideration, enclosed is a Site Plan application for the construction of a 11,000+/- square foot, two story building with outdoor play area, paved parking, landscaping, stormwater management and infrastructure improvements in support of the Applicant’s intended use of the building as a child care center for children ages 6 weeks to 6 years, to be called the “The Learning Experience” (“Project”).

The proposed facility will serve as a high-quality early childhood education and care center, providing a safe, supportive and engaging environment for children. The Learning Experience stands out due to their innovative approach to early childhood education, which is centered on their proprietary L.E.A.P.® (Learning Experience Academic Program) curriculum. This program encourages children to learn through exploration and hands-on activities, catering to their intellectual, social, and cognitive development. The L.E.A.P.® curriculum is designed to meet or exceed nationwide standards and is regularly updated to reflect the latest practices in early childhood education. It incorporates STEM-based learning and is structured around six developmental stages, ensuring that children are engaged in activities appropriate to their age and developmental level. The curriculum also includes unique enrichment programs such as music, engineering and fitness making it a comprehensive and well-rounded educational experience.

Moreover, the Learning Experience will offer an important community benefit by expanding access to early education opportunities and supporting working families. The project has been thoughtfully planned to minimize potential impacts while meeting all regulatory standards.
